OFFICIAL CONTEST RULES

Connoisseur Media Long Island (WALK 97.5 – WALK-FM, KJOY 98.3 – WKJY-FM, 103.1 MAXFM –
WBZO-FM, 94.3 The Shark – WWSK-FM, 104.7 WHLI-FM and 1100 WHLI-AM)
hereinafter referred to as the “Stations”

No purchase or payment is necessary to enter or win this promotion. A purchase or payment of any kind will not increase your chances of winning. By participating, each entrant fully and unconditionally agrees to be bound by and accepts these official Contest Rules.

1. Promotion Dates

The Stations, all owned and/or operated by Connoisseur Media, LLC (CONNCOs) are running a multi-station promotional contest (the “Contest”) from on or about January 11, 2023 at 12:00 am EDT which will end on or about February 5, 2023 at 11:59pm EDT (the “Promotion Dates”). The Grand Prize winner will be announced on or about February 6, 2023.

2. Entry / How To Win

- a. *Contestants listening to the stations during the “contest” period will be directed to a station specific website for instructions on how to register to win. On WALK-FM the contest will be referred to as the “Big Game Giveaway.” On WKJY-FM the contest will be referred to as the “Rihanna at the Big Game Contest.” On WBZO-FM the contest will be referred to as the “Big Game Fantasy Giveaway.” On WWSK-FM the contest will also be referred to as the “Big Game Fantasy Giveaway.” On WHLI-FM and WHLI-AM the contest will be referred to as the “Big Game Contest.”*
- b. *Contestants will visit www.WALKRadio.com/big-game, www.KJOY.com/big-game, www.1031MAXFM.com/big-game, www.943TheShark.com/big-game and/or www.WHLI.com/big-game during the “contest” promotional period to register to win by filling out and submitting an electronic entry form. Only one entry per person, per day, per station website will be valid.*
- c. *A physical entry form may also be obtained by sending a self-addressed stamped envelope to GLENDALE FLYAWAY CONTEST REQUEST c/o Connoisseur Media Long Island 234 Airport Plaza Blvd. Suite 5 Farmingdale, NY 11735. One entry per day per person using this method will be valid. Entries and entry requests that go undelivered will be disqualified. - d. *On or about February 6, 2023, Connoisseur Media Long Island Judges will choose a contestant by random draw from all eligible entries. The contestant will be notified via phone and will be awarded the Grand Prize.*

4. Winner Selection / Odds / Prizes

- a. *On or about February 6, 2023, Connoisseur Media Long Island Judges will choose a contestant by random draw from all eligible entries. The contestant will be notified via phone and will be awarded the grand prize.*
- b. *No one entry will have better odds of being selected.*
- c. *Odds of winning are based on number of entries received. Final odds of being selected the winner will only be calculable after the contest period ends on February 5, 2023 at 11:59pm EST and will be determined by the total number of eligible entries received during the contesting period.*
- d. *The entry selected as the winner will be notified via the phone number on the entry. If the contestant that submitted the selected entry is unable to be reached by February 6, 2023 at 5:00 PM Est. another entry may be selected at random. Once connection with the contestant that submitted the selected entry is made and verified, the winner will receive the Grand Prize as described below in exhibit B.*

5. Acceptance and Delivery of Prize

Contest winners agree on their own behalf and on behalf of their heirs, successors, representatives and/or assigns, to fully and forever release and discharge CONNCOS and each and all of its subsidiary and affiliated corporations, companies and divisions, its predecessors, successors and assigns, and its respective directors, stockholders, officers, employees and agents, of and from any and all claims, demands, agreements, contracts, covenants, actions, suits, causes of action, obligations, controversies, debts, costs, expenses, accounts, damages, judgments, losses and liabilities of whatsoever kind or nature in law, equity or otherwise, whether known or unknown, whether or not concealed or hidden which against it or any of it, they have had, may have had or now have, or which any of their heirs, representatives and/or assigns hereafter can, shall or may have for or by reason of any matter, cause or thing whatsoever, including but not in any respect limiting the generality of the foregoing, any and all claims which or might have asserted relating to this contest, and agrees to deliver an executed release form at the time of delivery of any prize(s). If a minor is a contest winner, the person's parent or legal guardian must sign said release on the winner's behalf.
